#### THIS WEEK'S MESSAGE, Sunday, May 17, 2020, "Let's Watch the Same Movie: 'I Am Not Your Negro' James Baldwin and Michelle Obama's Becoming. »

I plan for us to consider two documentaries in my message this Sunday, May 17th: **Michelle Obama's "Becoming"** now showing on Netflix, and **James Baldwin's "I Am Not Your Negro"** playing on Amazon Prime (or renting for \$3.99 on Amazon.)

I hope you will take the opportunity to watch one or both of the documentaries this upcoming week.

While Obama's documentary is intended for mass appeal - with an important message, and Baldwin's documentary is intended to enlighten and discomfort, I believe they have the same underlying theme. That theme is one of questioning and, yes, one of "becoming." Will America become a nation that overcomes its 400 year old sin - one that solving will create a truly great America, or one that, if ignored, will destroy us all?

Both documentaries speak to that question. Michelle Obama's message is uplifting, inspiring, and even joyous - with an undercurrent of sadness in the discriminations she and Barack have faced.

Baldwin's message is equally upsetting for many of the same reasons.

The issue of racism in our nation is not one I should ignore. I believe our congregation believes it shouldn't either. In that regard, we as thinking, reasonable, and loving people must regularly be reminded of the problem - in order for us not to become apathetic, but to instead be and become a spiritual community that is a part of the solution.

I look forward to meeting with you online this coming Sunday, May 17th. Just as with the last two films we've considered on Sunday morn-ings, there will be a Talkback time for your thoughts about the film and / or my message.

## Mid-Year Congregation Meeting - to be held via Zoom video conferencing - Sunday, June 7, 2020.

At the meeting members will be briefly updated on the GNH 2020 Budget and then asked to vote on an Amendment to GNH Bylaws - to allow for absentee or proxy voting for all future congregation meetings. This is an important Bylaw change and all members are encouraged to "attend" the meeting and vote. There will be voting provisions for those who cannot access the Zoom meeting. Details will be sent to all members. A Bylaw to allow for absentee voting has been requested by many members in the past. The Board voted unanimously at its meeting last Saturday to place the change before members at the upcoming mid-year meeting. A Quorum of 29 members will be needed at the mid-year meeting for a Bylaw change vote to take place. 75% of those attending will then be needed to approve the new Bylaw. The Board will hold an informational presentation and discussion on the change after an upcoming Zoom Sunday service.

# New Locks and Front Entry Keypad to be Installed Soon!

After a lengthy bid process that was delayed by the Covid crisis, the Board has approved a locksmith plan to install an electronic front door entry keypad - and change all locks to entrance doors to our building. This new update was paid for from funds generously given to GNH by the late Victor Soukup - and the expense was approved by the Board in 2019. Once installed, all existing door keys will no longer work. All members and groups renting space from GNH will choose their own 4 digit code to use for entry into the building. Key access to the office will be limited to staff and the Board President. Thank you to Sallie Ann Killian, Rev. Doug, David Hester, and Board President Sue Cline for managing the bid and installation process. **Our building security will soon be greatly improved - and made easier for all members** 

#### **Proposed Bylaws Change to Enable Absentee Voting**

A Congregational Meeting will be held Sunday, June 7 immediately following the service to consider the question of whether the congregation wants to enable voting by members who cannot be physically present at a congregational meeting.

Our current Bylaws, adopted in 2016 when The Gathering at Northern Hills was formed, require members to be present to vote.

In the past four years, there have been two extraordinary situations in which the congregation agreed to suspend that Bylaw and allow absentee ballots to be created and counted. There has been at least one vote recently where the Board did not allow an exception. We are now in another extraordinary situation of unknown duration which requires that the meeting at which we consider this question will have *no* members physically present in a single place. Many members have asked that we remove the requirement on physical presence. The Board has considered the issue in depth and will propose, at the first virtual Congregational Meeting of GNH, wording to revise the Bylaw that requires "presence."

The wording that the Board proposes has yet to be decided. We offer in this space several alternatives that achieve the goal of removing that provision, but which have various meanings and consequences. We ask members to consider the alternatives and communicate with Board members to let us know your thoughts and preferences. A meeting to present and discuss the alternatives will be held this coming Sunday, May 17 immediately after the service. We urge you to "Zoom" in and participate by listening to others and speaking your own thoughts. Our goal is to get a sense of what the congregation wants so we can craft the appropriate language to achieve what is wanted. Please read on to consider some of the alternatives.

First, here [in Article Five] is what our current Bylaws say about voting:

Eligibility for Voting – A Member shall be eligible to vote in annual or special meetings 30 days after signing a written declaration to be a Member. **Members must be present in or-der to vote at a congregational meeting.** 

The sentence in bold is what we are considering. Elsewhere in the article on Congregational Meetings, it says that "Decisions shall be made after a time of listening, discussion and dialogue."

#### HERE ARE SOME OPTIONS FOR AMENDING THE BYLAW

#### Option 1

Eligibility for Voting – A Member shall be eligible to vote in annual or special meetings 30 days after signing a written declaration to be a Member. Members must be present in order to vote at a congregational meeting.

Simply removes the mention of physical presence

Provides no guidance about voting (as opposed to voter) requirements

Presumably leaves voting requirements and procedures to Policy established by Board

#### **Option 2**

Eligibility for Voting – A Member shall be eligible to vote in annual or special meetings 30

Establishes "presence" as a requirement for voting

May preserve "listening, discussion and dialogue" capabilities for all "present"

Allows for various forms of electronic presence (Zoom-type conferencing, telephone, text?, email?

Requires more resources to run a physical and teleconferencing meeting simultaneously

Considers "virtually" vs. "electronically"

#### Option 3

Eligibility for Voting – A Member shall be eligible to vote in annual or special meetings 30 days after signing a written declaration to be a Member. Members must be present **or cast an authorized absentee ballot** in order to vote at a congregational meeting.

Requires preparation, delivery and return of official ballots on question(s)

Becomes problematic if a question changes while under consideration at the meeting

#### Option 4

Eligibility for Voting – A Member shall be eligible to vote in annual or special meetings 30 days after signing a written declaration to be a Member. Members must be present **or represented by proxy** in order to vote at a congregational meeting.

Puts burden on Members to find a proxy who will represents their views

Reserves some degree of "listening, discussion and dialogue" (by proxy)

Requires creation and use of a standard, official proxy authorization process

#### Option 5

Eligibility for Voting – A Member shall be eligible to vote in annual or special meetings 30 days after signing a written declaration to be a Member. <del>Members must be present in order to vote at a congregational meeting.</del> A Member who is unable to be present at an annual or special meeting may arrange to vote according to the GNH Policy currently in place.

Policy can be changed more readily than Bylaw (by majority vote of Board)

Policy still needs to be written

#### Option 6 ...

#### ONE MORE CONSIDERATION

Our Bylaws state:

**Quorum** – Unless otherwise stated in these by-laws, 30% of the Membership shall constitute a quorum at a congregational meeting.

Should members not physically present be included as part of the quorum?

Should members not physically present but connected electronically be included in the quorum?

Should all members certified to vote (via whatever means authorized) be counted in the quorum?

Please attend the information and discussion meeting following the service next Sunday, May 17 to present your views on these and other alternatives. When you have thoughts about this issue, you are encouraged to share them with any board member

**online.** The Board will inform all members once this has been established.
